WizWe is a startup company that aims to "guide 10 billion people to their desired selves with a habit-forming platform," and provides the value of habit-forming through its proprietary habit-forming platform, 'Smart Habit.'

'Smart Habit' is a behavior continuation platform designed to eliminate the phenomenon of giving up after a few days, based on habit formation theories derived from the behavioral data of 40,000 individuals by experts in social psychology and behavioral economics. By building rapport (a close relationship of trust) through conversations between habit formation supporters and users, the platform thoroughly removes factors that lead to dropout and promotes the continuation of behaviors.

In an era of super-aging society where people are expected to live up to 100 years, WizWe aims to contribute to improving people's health and well-being by actively working to extend healthy life expectancy and solve issues in the healthcare field.
