TechDoctor's SelfBase is a digital biomarker* development platform that enables easy visualization and analysis of continuous and long-term data acquired from multiple wearable devices and medical equipment. SelfBase is used across various industries, including pharmaceutical companies and medical/research institutions. In addition, Health Portal is a platform that uses data for healthcare services, health policies, and programmed medical devices (SaMD). By linking accumulated device data and incorporating digital biomarkers, it can provide new value to users.
